A Bill

further to amend the Khyber Pakhtunkhwa Judicial Academy Act, 2012.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Judicial Academy Act, 2012 (Khyber Pakhtunkhwa Act No. IV of 2012), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement,--- (1) This Act may be called the Khyber Pakhtunkhwa Judicial Academy (Amendment) Act, 2018.
 - (2) It shall come into force at once.
- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. IV of 2012.--- (1) In the Khyber Pakhtunkhwa Judicial Academy Act, 2012 (Khyber Pakhtunkhwa Act No. IV of 2012), hereinafter referred to as the said Act, in section 2,-
 - (a) for clause (f), the following shall be substituted, namely:
 - "(f) "Endowment Fund" means the Endowment Fund established under section 12-A of this Act; and
 - (b) after clause (f), as so amended, the following new clause shall be inserted, namely:
 - "(f-i) "General Fund" means the General Fund of the Academy established under section 12 of this Act;".
- 3. Substitution of section 12 of the Khyber Pakhtunkhwa Act No. IV of 2012.--- In the said Act, for section 12, the following shall be substituted, namely:
 - "12. General Fund.---(1) There shall be a General Fund to which all the income shall be credited and from which all the expenditures of the Academy shall be met.
 - (2) The sources of income of General Fund shall be-
 - (a) grants made by the Federal Government;
 - (b) grants made by Government;
 - (c) sale proceeds of the property and publications of the Academy; and
 - (d) fees, charges or any other sum received by the Academy from any lawful source.
 - (3) The General Fund shall vest in the Academy and the money to the credit of the General Fund shall be kept in a designated account in the Government Treasury or with the approval of the Board, in a Scheduled Bank.".



- 4. Insertion of section 12-A in the Khyber Pakhtunkhwa Act No. IV of 2012.—(1) In the said Act, after section 12, as so amended, the following new section shall be inserted, namely:
 - "12-A. Endowment Fund.---(1) There shall be an Endowment Fund to be known as the Khyber Pakhtunkhwa Judicial Academy Endowment Fund.
 - (2) The Endowment Fund shall be used for such purposes and operated in such manner as may be determined by the Board from time to time.".
- 5. Amendment of section 13 of the Khyber Pakhtunkhwa Act No. IV of 2012.--- In the said Act, in section 13, in sub-section (2); before the word "Fund", the word "General" shall be inserted.

STATEMENT OF OBJECTS AND REASONS

It is desirable to amend Khyber Pakhtunkhwa Judicial Academy Act, 2012. Hence, this Bill.
