

## **SUMMARY OF PROCEEDINGS**

2. SUSPENSION OF RULE-124 UNDER RULE-240. In suspension of Rule 124 under rule 240 the following Joint resolutions were moved and unanimously adopted by the House.

i. Mr. Shoukat Yousafzai, Resolution regarding non issuance of advertisement to those Print and electronic Agencies which stopped /imposed cut on salaries of their journalist or partial dismissal of their employees/journalist and to take the issue with Federal Government for amicable resolution.

ii. Mr. Sahibzada Sanaullah, MPA regarding Pakistanis labour issues in Saudi Arabia.

iii. Sardar Hussain Babak, MPA regarding opening of Tourkham border for trade with Afghanistan as per direction of the Prime Minister of Pakistan.
