MINOR MINERAL REPORT IN RESPECT OF ADM SWAT

It is submitted that different areas of minor minerals in the jurisdiction of District Swat were advertised for auction in leading newspapers in 2015, where only two areas were granted in auction proceeding.

It is worth to mention here that in minutes of the meeting of Provincial Cabinet held on 20/05/2016 under the Chairmanship of Chief Minister Khyber Pakhtunkhwa, where the following decision had been made:-

“Cabinet further directed that no lease will be charged for Minor Mineral (Sand, Shingle) till the report of the Cabinet Committee”

Later on, the Provincial Cabinet Committee in its meeting held on 15/05/2019 vide agenda item No 11 has decided to auction Minor Minerals in Malakand Division. Accordingly, 11 blocks of Minor Minerals were advertised in the leading newspapers for auction on 07/07/2019. The said areas were auctioned in the office of Deputy Commissioner Swat on 01/08/2019 and granted 10 areas as per detail given below: -

After issuance of allotment letter, when the lessees visited the area and were about to start mining operation, the locals created hindrance in the mining operation of the lessee due to the reason that no schedule rate specified in the Khyber Pakhtunkhwa Mines & Minerals Act-2017. In this regard several meetings have been conducted with local administration for fixation of minor minerals schedule rate and its regularization in the district, but no fruitful result has been achieved.

Record reveal that, the Deputy Commissioner Swat imposed section 144 against illegal mining in river Swat and the field staff of regional office patrolling throughout District Swat for stoppage of illegal mining but they face more difficulties as most of the time police were not being provided for accompanying the field staff due to one reason or the other, in this regard the ADM concerned requested the DPO Swat for police cooperation in stoppage of illegal mining/transportation of minerals in the area vide letter No. 2518/MDW/SWT/Minor Minerals (03)/2018, dated 16/10/2019.

Furthermore, locals of the area and others throughout the district resisted auction of minor minerals and created hindrance in regularization of minor minerals granted leases.

It is also pertinent to mention here that the concerned regional office requested the DC Swat being chairman of the District Auction Committee regarding the stoppage of unauthorized mining operation of minor mineral and fixation of rate per ton in District Swat vide endorsement letter No. 2458-65/MDW/SWT/Minor Minerals (03/2018) dated 07/10/2019 and Endorsement Letter No. 2524-28/MDW/DDM/Illegal Mining/Assessment, dated 16/10/2019 and letter No. 2554 /MDW/SWT/Minor Minerals (03/2018) dated 24/10/2019. It is pointed out that the period of one year Mining Leases of Minor Minerals was started, and meanwhile, installments of the blocks were due against the parties. All the lease holders failed to deposit installments of remaining auction money despite of notices. Accordingly, summaries for cancellation have been forwarded to H/Q office. The Licensing Authority approved the cancellation summaries, forfeited the securities in favor of government and directed this office to auction the areas immediately in the best public interest. In compliance, the Assistant Director Mineral Development Swat Office cancelled the leases.

Further, the office of Assistant Director Mineral Development Swat Office processed new blocks for auction of minor minerals with the consultation of C&W department, Fisheries and irrigation department, while the ex-lessees have filed appeals before the Appellate Authority detail of which is given below: -

The same detail has been forwarded to the office of Deputy Commissioner Swat for fixation of reserve price and fixation of date for open auction of the said blocks. Accordingly, a meeting of District Auction Committee has been fixed on 16/02/2021 in the office of Deputy Commissioner Swat for the purpose. The Deputy Commissioner directed all Assistant Commissioner to recheck the proposed prices and come with concrete suggestions/realities on ground to the next meeting. While auction proceeding was in progress, the Honorable Peshawar High Court Peshawar imposed ban on every kind of mining activity on river bed in Malakand Division.



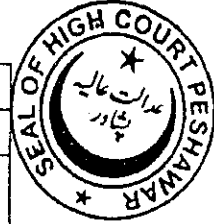

ensure that such activities cease forthwith and more so, to ensure that the River Kabul is restored/rehabilitated to its old historical status/position. We have noted with a degree of concern that the illegal mining activity has continued in various rivers of the province and through such illegal excavation of sand and stones, the water table has gone down to a dangerous level. It is common knowledge that we are already facing an acute shortage of water and if the situation is not remedied, the water would become a rare commodity. It is another bad example of misgovernance. Mr. Wasal Khan, Focal Person is directed to ensure that no illegal activity of excavation of any kind including sand or shingle is undertaken from River Kabul. He shall feel free to get the assistance of the concerned Deputy Commissioner and the DPO in this regard and submit his progress report within three weeks of course with pictures.
