Dear Sir,

I am directed to enclose herewith a copy of the Assistant Chief (PSDP Section) P&D Department letter No. C/PSDP/P&DD/Health/1-65/2018 dated 18/04/2018 on the subject noted above and to state that the subject scheme was cleared by PDWP in its meeting held on 04-08-2011 at a total cost of Rs.159.801 million (Capital Rs.95.570 million, Revenue Rs. 64.23 million) to be funded out of PM Directive under PSDP (PWP-II). The PC-I was sent to Federal Government by the P&D Department on 8/12/2011 for approval of the competent forum. In response, the Federal Government advised that the subject scheme, as per Prime Minister's directive is financed under PWP-II which is being managed by the PM Secretariat/Cabinet Division & is not processed for approval through forum of CDWP/ECNEC (**copy enclosed**).

02. Administrative Approval of the scheme was issued at a total cost of Rs.159.801 million on the directions of P&D Department through a note accordingly (**copy enclosed**). An expenditure of Rs. 100.00 million has been incurred under the scheme till date.

03. Now P&D Department communicated that as per decision of 5th Coordination Meeting held on May 10th, 2018, the case of release of Rs. 9.905 million to the subject scheme was taken up with Cabinet Division, which was regretted to provide the funds on account of closing down of People Works Program-PWP, therefore, they have requested to take up the case with Finance Division (**copy enclosed**).

04. In view of the above it is requested that modified PC-I of the subject scheme may be furnished to this Department at the earliest for further processing, please.
