# SUMMARY OF PROCEEDINGS OF 30TH SEPTEMBER 2009

The House commenced with recitation from the Holy Quran followed by Urdu translation at 10:35 A.M. Mr. Khushdil Khan Advocate, Speaker, Provincial Assembly was in the Chair.

# Quorum

Want of quorum was pointed out by Mr. Akram Khan Durrani, Leader of Opposition and Sikandar Hayat Khan Sherpao. Bell was sounded for two minutes but quorum did not complete and the House was suspended for fifteen minutes.

The House resumed at 11:04 A.M.

Syed Qalbe-Hassan, MPA, Mr. Akram Khan Durrani, Leader of Opposition raised a point regarding the recent blasts in Kohat and Bannu respectively and demanded for early compensation for the deceased, injured people and for the assessment of damaged property by Works & Services Department. Dua was offered to the deceased etc by Hafiz Akhtar Ali, MPA as suggested by Mr. Saqib Ullah Khan Chamkani, MPA.

Mr. Bashir Ahmad Bilour assured that compensation would be given to the affecties soon on the provision of relevant record by the concerned District Coordination Officers.
