### SUMMARY OF PROCEEDINGS OF THE NINTH SESSION OF NWFP ASSEMBLY

Wednesday 7th October, 2009

- x) An identical amendments moved by Mr. Saqibullah Khan Chamkani , MPA and Mr. Abdul Akbar Khan, MPA in sub-clause (1) of clause (19) after para (a) was adopted and stood part of the Bill.
