### ANNOUNCEMENT OF RULING

- The Chair announced ruling reserved on 11th March, 2010 on a point of order raised 4. by Mr. Abdul Akbar Khan, MPA with regard to Al-Haj Sanaullah Khan Miankhel, MPA, who was absent from the session of the Assembly for forty (40) consecutive days and quoting rule-51 of the Provincial Assembly N.W.F.P, Procedure and Conduct of Business Rules, 1988 under which his seat be declared vacant.
- The Chair over ruled the point raised by Mr. Abdul Akbar Khan, MPA and stated that 5. under Article 64 of the Constitution the House may declare the seat of a member vacant if, with out leave of the House, he remains absent for forty (40) consecutive days of its sittings. The word "sitting" has been defined in to to in sub rule (1) para (z) of rule-2. The previous two Assembly Sessions were summoned from 30th September to 15th October, 2009 and 31st December, 2009 to 15th March, 2010 and according to the record, the Assembly has actually met for 32 days till date and in view of the Constitution provision as explained none of the Member of this Assembly has absented himself for forty (40) consecutive sittings.
