

SUMMARY OF PROCEEDINGS OF 7TH JANUARY 2011
16TH SESSION

The proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 11:04 A.M.. Mr. Kiramattullah Khan, Speaker, Provincial Assembly was in the Chair.

2. QUESTION HOUR:
