Arbab Muhammad Ayub Jan, Minister for Agriculture/ Chairman Cabinet Committee on Revenue and Mukhdumzada Syed Murid Kazim Shah, Minister for Revnue and Estate in their winding up speeches informed the House that taking the cognisance of the complaint of corruption by Revenue officials the Cabinet has constituted a committee under the Chairmanship of Arbab Muhammad Ayub Jan, for restructuring and improvement of the Department, they said the Committee has finalized the recommendations and would be discussed with Mr. Speaker in his Chamber.

- 8. On conclusion of the discussion, the Chair directed that:
 - a) relevant Laws needs to be revisited by the Special Committee.
 - b) patwaris must establish their offices (patwarkhana) in its respective Halqa instead of establishing offices in the city.
 - c) detail of fee for all sorts of transaction should be displayed in front of the office of the patwari in visible place.
 - d) assets of all patwaries should be provided to the Special Committee in two weeks time.
 - e) FIA, NAB and likewise agencies must take action against the field revenue officials involved in corruption cases to curb the menace of corruption in the Department and weekly progress report must be intimated to the Assembly.
