^{4.} In pursuance of Article 123 (2) read with Article 124 of the Constitution, Mr. Muhammad Hamayun Khan, Minister for Finance laid the Supplementary Schedule of Authorized Expenditure -2010-11 in the House.

- 5. On conclusion of the Budget Business, the Leader of the House, Mr. Ameer Haider Khan Hoti, informed the House regarding the efforts of Provincial Government in preparation / allocation of funds, NFC Award, Mega projects in the Province, and said that Provincial Government will form a jirga comprising all political parties to take up the issue to uncap net hydel profit with the Federal Government. He expressed that in future new discoveries of Oil and gas will raise the revenue of the Province. In this regard own oil and gas company would very soon launch a joint venture with a foreign oil firm in Southern districts, which had huge deposits of oil and natural gas. He assured the House that Rs.700 million of the total royalty would be spent on uplift schemes in those districts where oil and gas were explored. He urged the Members belonging to Southern districts to identify mega projects of major impact in their respective area. He further informed that Government is focusing on hydel power generation in the Province. In this connection ground breaking ceremony of two projects in Malakand division would be held in January. Terming terrorism one of the major challenges for the Government, he reiterated that Provincial Government would negotiate with those groups, who laid down weapons and accept the state's writ.
- 6. The Chair read out prorogation order of Governor, Khyber Pakhtunkhwa made under article 109 (b) of the Constitution and consequently the session of the Assembly was prorogued.
