### ADJOURNMENT MOTION

  - c) Clause 23 (2)
  - d) Clause 12 (2)
  - e) Clause 12 (3)
- 5. Mr. Saqibullah Khan Chamkani, MPA while commenting on his proposed amendments in Chapter VI of the University of Peshawar Bill, 2011, was of the view that when funds would be provided to the University from the Provincial Consolidated Fund why the Audit should not be conducted by the Audit General of Pakistan. He said that prior to the 18<sup>th</sup> Constitutional Amendment the funds to the Universities were provided by the Federal Government, but now it was the responsibility of the Province, therefore, the Province should be having the powers to check the use of those funds. He referred to the Functions and Powers of Auditor-General envisaged in Article 169 of the Constitution and asked whether the University is not an authority or body established by the Province and whether the said Article can be attracted to the Universities or not. He sought ruling from the Chair in this regard, the Chair reserved ruling on the point raised by Mr. Saqibullah Khan Chamkani, MPA.
