### 5. SUSPENSION OF RULE-124 UNDER RULE-240.

In suspension of rule-124 under rule-240 Mr. Saqib Ullah Khan Chamkani, MPA moved resolution with regard to amendment of Article 226 of the Constitution in order to exclude Senate Election on secret ballot, as in case of Prime Minister and Chief Minister to enhance transparency and discourage horse trading, but was kept pending by the House.

6. Upon the motion of Barrister Arshad Abdullah, Minister for Law, Parliamentary Affairs and Human Rights, the House relaxed rule 245 and allowed Election Commission of Pakistan to Conduct Senate election on 2<sup>nd</sup> March 2012 in the Assembly Chamber.
