- Amid ensuing heavy snowfall, the District's only transportation route Lowari Top shall remain closed for about five months leaving the District Chitral inaccessible to the remaining part of the country. According to a letter issued by the National Highway Authority, the under-construction tunnel, that remains the only transportation facility for nearly 500,000 people of Chitral, will be closed during winter season, due to sensitive nature of work.
- The Provincial Government, acknowledging gravity of the situation, was supposed to take up the matter with the Federal Government and Korean construction Company SAMBO. Ironically, it does not take the matter seriously. We are citizens of Pakistan. We shouldn't be treated like we don't belong here. For about five months, we will be like caged birds left to the mercy of God, if no proper arrangement both for light and heavy traffic is made well in time. The closure of heavy traffic will seriously impact the life of people in Chitral and even supply of edibles items to the valley will also be halted which will put the whole population in starvation.
- In order to resolve the issue this resolution is presented before the House that the Provincial Government of Khyber Pakhtunkhwa may kindly approach Federal Government, National Highway Authority and Korean company

SAMBO to allow heavy traffic as well through the Lowari Tunnel during winter season.
