3. AUDIT REPORTS OF THE AUDITOR GENERAL OF PAKISTAN ON ACCOUNTS OF GOVERNMENT OF KHYBER PAKHTUNKHWA FOR THE YEAR, 2014-15. Mr. Muzaffar Said, Minister for Finance laid the following reports of the Auditor General of Pakistan on Accounts of Government of Khyber Pakhtunkhwa for the year 2014-15 and the House referred it to the Public Accounts Committee:-

4. GENERAL DISCUSSION ON ANNUAL BUDGET 2017-18. On conclusion of the Annual Budget Business, 2017-18 the Leader of the House, Mr. Pervaiz Khattak, informed regarding the efforts of the Provincial Government in preparation of budget. He highlighted the achievements of his Government and insisted that the Province was on the path to progress after land mark reforms in different sectors especially Health, Education, Police and Industry. He said political elites and lawmakers had facilitated the timber mafia in the past by approving forest policies in the name of windfall trees. The out laws had harvested green trees worth Rs. 200 billion during the last 10 years but the present Government has scrapped the wind fall and other ill-planned policies. Now the Pakistan Army is engaging to cheek the illegal harvesting of natural forests in the province and act against culprits. He said the ongoing billion tsunami trees project in the province is very successful. He claimed that the WWF had reported that the success

rate of the said project was 82 percent. He announced regularization the services of NTS, adhoc and contractual employees. While the up gradation of all employees would also be made simultaneously. He said in 2013 when the PTI formed government the province was very serious and the system was not delivering. Now with the help of God the situation has largely improved. The province is now moving forward after improving in law and order situation. He also sought suggestions from the Opposition benches for the betterment of the Province. He announced three honourium for the employees of the Assembly Secretariat.
