**5. LAYING OF THE KHYBER PAKHTUNKHWA SUGAR FACTORIES CONTROL (AMENDMENT) ORDINANCE, 2020.** Mr. Khaleeq Ur Rehman, Advisor to C.M laid the above captioned Ordinance in the House.

**6. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA DOMESTIC VIOLENCE AGAINST WOMEN (PREVENTION AND PROTECTION) BILL, 2021.** Upon the motions of Mr. Hisham Inam Ullah, Minister for Social Welfare, the House considered the above captioned Bill clause by clause and passed with the amendments in the following clauses,-

**8. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA MINISTERS (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) BILL, 2021.** Upon the motions of Mr. Kamran Khan Bangash, Special Assistant to C.M, the House considered the above captioned Bill clause by clause and passed.

**9. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA BOARD OF TECHNICAL AND COMMERCE EDUCATION BILL, 2021.** Upon the motions of Mr. Abdul Karim Khan, Special Assistant to C.M, the House considered the above captioned Bill clause by clause and passed with amendments in the following clauses,-

**11.
