- 10. CONSIDERATION & PASSAGE OF THE KHYBER PAKHTUNKHWA SENTENCING BILL, 2021. Upon the motion of Minister for Parliamentary Affairs and Labour, the House took into consideration the above-captioned Bill. From clause 1 to 18 of the Bill were considered and stood part of the Bill while consideration of its remaining clauses were deferred for another day upon the request of the Minister for Parliamentary Affairs.
