- 6. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA CONTINATION OF LAWS IN ERSWHILE PROVINCIALLY ADMINISTERED TRIBAL AREAS BILL, 2018. Upon the motions of Mr. Sultan Muhammad Khan, Minister for Law, the above-captioned Bill was taken-up for consideration at once. Clauses 1 to 2 stood part of the Bill. Mr. Salah ud din, MPA withdrew his amendment in clause 3 whereas Malik Zafar Azam, MPA moved his amendment in the said clause.

Upon the request of Mr. Fakher Jehan, MPA further consideration of the Bill was deferred for giving an opportunity to Treasury and Opposition benches for building consensus on the said legislation.

7. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA CHILD PROTECTION AND WELFARE (AMENDMENT) BILL, 2018. Upon the motions of Mr. Sultan Muhammad Khan, Minister for Law, the above captioned Bill was considered clause by clause and passed by the House.
