**6. INTRODUCTION OF THE KHYBER PAKHTUNKHWA EMPLOYEES OF THE ELEMENTARY & SECONDARY EDUCATION DEPARTMENT (APPOINTMENT AND REGULARIZATION OF SERVICES) (AMENDMENT) BILL, 2018.** Mr. Zia Ullah Khan Bangash, Special Assistant to C.M for Elementary and Secondary Education introduced the above captioned Bill in the House.

**7. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA MEDICAL TEACHING INSTITUTIONS REFORMS (AMENDMENT) BILL, 2018.** Upon the motions of Mr. Hisham Inamullah Khan, Minister for Health, the House considered the above captioned Bill clause by clause and passed with the following amendments,-

(i) sub-clause (ii) of clause 3 deleted;

(ii) the existing clause 10, occurring for second time, clauses 11, 12, 13, 14, 15, 16, 9 occurring for the second time, 17, 18, 19, 20 and 21 were renumbered as clauses 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22 and 23, respectively;

(iii) in clause 19, as so renumbered, for brackets and figures "(iii)" and "(ii)", the brackets and figures "(ii)" and "(iii)" were substituted, respectively; and

(iv) in clause 23, as so renumbered, sub-clause (ii) was deleted.
