4. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA EMPLOYEES OF TRANSPORT DEPARTMENT (REGULARIZATION OF SERVICES) (AMENDMENT) BILL, 2018. Upon the motions of Mr. Sultan Muhammad Khan, Minister for Law, the above captioned Bill was considered clause by clause and passed by the House.

5. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA EDUCATION EMPLOYEES FOUNDATION BILL, 2018. Upon the motions of Mr. Sultan Muhammad Khan, Minister for Law, the above captioned Bill was considered clause by clause and passed by the House with the following amendments,-

- (i) Addition of the word “/her” in paragraphs (c) and (d) of sub-clause (2) of clause 4.
- (ii) Deletion of clause (i) of sub-clause (1) of clause 5 and renumbering of remaining clauses.
- (iii) Substitution of figure “XI” by figure “X” in sub-clause(2) of clause 5.
- (iv) Substitution of word “six” by “four” in proviso of sub-clause (1) of clause 6.
- (v) Deletion of sub-clause (5) of clause 6 and renumbering of remaining sub-clauses.
- (vi) Deletion of the word “suspend” in paragraph (g) of sub-clause(2) of clause 7.
- (vii) Deletion of paragraph (h) in paragraph (g) of sub-clause(2) of clause 7.
- (viii) Substitution of existing paragraph (i) of sub-clause(2) of clause 7 as proposed by Mr. Salahuddin, MPA.
- (ix) Deletion of paragraph (l) of sub-clause(2) of clause 7.
- (x) Addition of new paragraphs (c), (d) and (e) as proposed by Mr. Salahuddin and Inayatullah, MsPA and renumbering of remaining paragraphs.
- (xi) Insertion of the words “and report shall be submitted to the Provincial Assembly of Khyber Pakhtunkhwa”, after the word “Pakistan” in sub-clause(2) of clause 12.
- (xii) Substitution of word “Board” by the words “Managing Director” in clause 15.

6. CONSIDERATION AND PASSAGE OF THE KHYBER PAKHTUNKHWA EMPLOYEES OF THE ELEMENTARY AND SECONDARY EDUCATION DEPARTMENT (APPOINTMENT AND REGULARIZATION OF SERVICES) (AMENDMENT) BILL,
