6. SUSPENSION OF RULE-124 UNDER RULE-240. In suspension of Rule 124 under rule 240 the following joint resolution moved by Mr. Liaqat Ali, MPA was unanimously adopted by the House,-

پاکستان ایک پرامن ملک ہے جو اپنے پڑوسیوں کے ساتھ برادرانہ تعلقات کا متمنی ہے لیکن اگر کسی پڑوسی یا بیرونی جارحیت کے نتیجے میں پاکستان کی سالمیت اور خود مختاری خطرے میں پڑی تو پاکستان کو اس کا جواب اچھی طرح دینا آتا ہے، تاریخ اس بات کی گواہ ہے۔

لہذا یہ اسمبلی صوبائی حکومت سے مطالبہ کرتی ہے کہ وہ وفاقی حکومت سے سفارش کرے کہ بھارت کے سفیر کو طلب کر کے اس واقعے کی مذمت کرے اور بھارت کو واضح الفاظ میں یہ بتا دیا جائے کہ اگر آئندہ اس نے ایسی حرکت کی تو پاکستان اپنے دفاع کا حق رکھتے ہوئے اسے منہ توڑ جواب دے گا۔
