

## **SUMMARY OF PROCEEDINGS OF MONDAY,**

### **THE 15TH JULY, 2019**

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 11:20 A.M. Mr. Babar Salim Swati, Chairman from the Panel of Chairman was in the chair.
