SUMMARY OF PROCEEDINGS

MONDAY, THE 30TH DECEMBER, 2019

Proceedings of the House commenced with recitation from the Holy Quran followed by its Urdu translation at 02:30 P.M. Mr. Mushtaq Ahmad Ghani, Speaker, Provincial Assembly was in the chair.

- **2. QUESTION HOUR.** Question Hour was suspended by the House.
- 3. Ms. Nighat Orakzai, MPA raised the issue of child abuse cases in the Province followed by a resolution Notice No. 589 moved by Ms. Asiya Saleh Khattak recommending severe punishment for offenders in the cases of sexual abuse of minor children by amending the Khyber Pakhtunkhwa Child Protection Act. Upon the motion of Ms. Nighat Orakzai and other Members, the House empowered the Honorable Speaker to constitute a Special Committee comprising of such Members as appointed by Him. The House also resolved that the terms of reference for the Committee shall be framed out of the debates on the issue. The Law Minister suggested the following TORs for the Committee,-
- (a) Revision of existing laws on the subject for severe punishment;
- (b) Suggesting improvements in the existing laws; and
- (c) Suggesting measures for sensitization of society over the issue.
- (d) Resolution Notice No. 589 was also referred to the Committee. **Social Welfare Department.**
