ORDER

Whereas, the Consumer Protection Act, 1997 (Khyber Pakitunkhwa Act No. Vi of 1997), obligates the consumer protection council to protect the rights of consumers.

Whereas, Section 10(1)(d) of Consumer Protection Act, 1997 grants consumers the rights of redressal against unfair practices of unscrupulous exploitation.

Whereas, the Board of Intermediate and Secondary Education Peshawar being the regulating authority has already issued letter. Reference letter -No: 172 DRD/80522 dated 13.05.2016 that only tuition fee would be charged in the months vacation and no transport charge or any other would be levied.

Whereas, the parents have complained about the unfair practices of the provide schools by demanding advance fee and have shown their inability to pay the same

Whereas, it was agreed in the meeting of private schools association and heads of private schools in Peshawar held on 19th May 2016 that the students wood be required to produce pass certificate of their previous school for admission in new school.

Thereupon, it was agreed that the schools will charge only tuition fee from students and no other miscellaneous/hidden charges will be levied on students.

Therefore, in the light of above development the Consumer Protection Council agrees in its meeting held on 25-05-2016 that the advance fee for vacations shall not be charged by the schools. The parents would be liable to deposit only tuition fee for each month separately on due time.

Moreover, while the process for evaluation of justification for hike in schools fee by Consumer Protection Council is carried out there shall be no increase in fee by any school.
