

In pursuance of the Govt. of Khyber Pakhtunkhwa, Establishment Department Notification No. SOE-II9ED)3(29)2018-19 dated 10.12.2019, the competent authority has been pleased to assign the following duties of AC(HQ)/Deputy Administrator Auqaf, with immediate effect:-

- i. To assist the Administrator Auqaf in affairs of Auqaf Organization as provided under the Khyber Pakhtunkhwa Waqf Properties Ordinance, 1979 (Ordinance IX of 1979) and the West Pakistan Waqf Properties (Administration) Rules, 1960 or rules frame from time to time;
- ii. To supervise the Auqaf field staff and issue directions from time to time in relation with the Waqf Properties in order to ensure safeguarding the interests of Auqaf Organization;
- iii. To work as Assistant Collector Grade-I;
- iv. To take immediate action and convey recommendations/advice to the Administrator Auqaf or Chief Administrator Auqaf if someone violates the Auqaf Laws/Rules or encroaches the Waqf Properties/Lands;
- v. To represent the Auqaf Department/Organization throughout the District;
- vi. To supervise the duties of Religious Affairs, by establishing close liaison with the concerned District & Teshil Khateeb.
- vii. The Area Manager concerned shall submit report/cases en-route with the AC(HQ)/Deputy Administrator Auqaf to Chief Administrator Auqaf or Administrator Auqaf. The AC(HQ)/Deputy Administrator Auqaf shall ensure timely submission/disposal of such reports/cases.
- viii. To perform any other duty assigned to them by the Secretary/Chief Administrator Auqaf.


