No. PA/NWFP/Legis-I/2005/21460.—The North-West Frontier Province (Amendment of Laws) Bill, 2005 having been passed by the Provincial Assembly of North-West Frontier Province on the 4th July, 2005 and assented to by the Governor of the North-West Frontier Province on 4th August, 2005 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE (AMENDMENT OF LAWS) ACT, 2005.

(N.-W.F.P. ACT NO. XII OF 2005)

[First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), dated the 5th August, 2005].

AN
ACT

to amend certain laws.

WHEREAS it is expedient to amend certain laws;

It is hereby enacted as follows:—

1. *Short title and commencement.*—(1) This Act may be called the North-West Frontier Province (Amendment of Laws) Act, 2005.

(2) It shall come into force at once.

2. *Amendment of certain laws.*—The laws specified in column 3 of the Schedule to this Act are hereby amended to the extent specified against each in column 4 of the said Schedule.

(5) If the Controlling Authority is satisfied that any proceeding of a Board or a committee is not in conformity with the provisions of this Ordinance, the Controlling Authority may, without prejudice to the foregoing provisions of this section, by order in writing, annul such proceeding.

Provided that before making any such order the Controlling Authority shall, through the Chairman, call upon the Board or the committee, as the case may be, to show cause why such order should not be made.

(6) The Controlling Authority may, from time to time direct the Board to conduct its affairs, and to perform its functions in such manner as may be specified.

(7) The Controlling Authority may require a Board to furnish it with:

- (i) any return statement, estimate, statistics or other information regarding any matter under the control of the Board; or
- (ii) a report on any such matter; or
- (iii) a copy of any document in the charge of the Board and the Chairman shall comply with every such requisition.

(8) Notwithstanding anything to the contrary contained in this Ordinance, the Controlling Authority may-

(1) place the services of any of the officers or other employees of any Board at the disposal of Government or any other Board or institution of such period and as may be determined by him: provided that such terms and conditions shall not be less favourable than those admissible to him immediately before his transfer;

(ii) make appointment to any post in the Board in a capacity from persons in the service of Pakistan from other officers or employees of any other Board and

(iii) make regulations concerning efficiency and discipline of officers and other employees of the Board.

Officers of the Board

The following shall be the officers of the Board:

- (i) the Chairman
- (ii) the Secretary;
- (iii) the Controller of Examination; and
- (iv) such other officers as may be appointed by the Board.

Chairman

The Chairman shall be a whole time officer and shall be appointed by the Controlling Authority on such terms and conditions as may be determined by the Controlling Authority.

to transfer any movable and immovable property belonging to it;
to hold and manage endowments;
to regulate and decide all administrative matters including the creation and abolition of posts under the Board. Provided that a post carrying an initial basic pay 17 and above shall not be created without the prior approval of the Controlling Authority;

- ii) to appoint such officers and staff as it may consider necessary for the performance of its functions and define their duties and conditions of service;
- ;) to make provisions for building, premises, furniture apparatus, book and other means required for carrying out the purposes of this Act/Ordinance;
-) to sanction or incur such expenditure as may be necessary for carrying out the purposes of this Act/Ordinance; and
- xi) to do all other acts necessary for carrying out the purposes of this Act/Ordinance.

The Board may delegate any of its powers to its Chairman or any officer of the Board or to a committee or sub committee appointed by it, as it may deem fit.

Controlling Authority

- 11. The Governor, North-West Frontier Province, or his nominee shall be the Controlling Authority of all the Boards in NWFP.

Power of the Controlling Authority

- 12. (1) The Controlling Authority shall have the power to cause an inspection to be made, by such person or persons as it may direct, of the offices, activities and funds of, and the examinations conducted by, a Board, and to cause an enquiry to be made in like manner in respect of any matter concerning a Board.
- (2) The Controlling Authority shall communicate to a Board the result of such inspection or enquiry and may advise a Board to take such action and within such period as may be specified.
- (3) The Board shall report to the Controlling Authority the action it proposes to take or has taken on such communication.
- (4) Where the Board does not, within a reasonable time, take action to the satisfaction of the Controlling Authority, the Controlling Authority may, after considering any explanation made by the Board, issue such directions as it thinks fit, and the Chairman shall comply with such directions.

- (5) If the Controlling Authority is satisfied that any proceeding of a Board or a committee is not in conformity with the provisions of the this Ordinance, the Controlling Authority may, without prejudice to the foregoing provisions of this section, by order in writing, annul such proceeding.
- Provided that before making any such order, the Controlling Authority shall, through the Chairman, call upon the Board or the committee, as the case may be, to show cause why such order should not be made.
- (6) The Controlling Authority may, from time to time direct the Board to conduct its affairs and to perform its functions in such manner as may be specified.
- (7) The Controlling Authority may require a Board to furnish it with:
- (i) any return statement, estimate, statistics or other information regarding any matter under the control of the Board; or
- (ii) a report on any such matter; or
