#### Ombudsperson Office February 1, 2019 to January 7, 2020

#### The progress of the Ombudsperson's Office till date;

- The Ombudsperson office operationalised on February 1<sup>st</sup>, 2019, on makeshift office and staff. However, the temporary arrangements have been provided by Secretary Social Welfare on February 11<sup>th</sup> 2019, and since then the Ombudsperson is using the department's premises.
- 2. In nine months' time, **58** complaints have been filed and **21** relevant cases are in progress , **5** cases have been decided and rest of the complaints have also been facilitated through linking with the relevant institutions.

- 3. The Khyber Pakhtunkhwa Enforcement Women Rights to Property Act, 2019 has extended the Ombudsperson jurisdiction in the cases related property. In two months' time 8 applications filed. However, the Ombudsperson Secretariat is still working without Registrar and Investigation Officers.
- 4. An initial database on the status of Inquiry Committees is in progress and notices have been issued to the relevant institutions mentioned in Section 4(d), of the Khyber Pakhtunkhwa Protection against Harassment at the Workplace Act, 2018. To establish Standing Inquiry Committees according to the law, more than 1100 notices issued to the Government & Non-Government institutions mentioned in the Act.
- 5. As response to above mentioned notices, 149 Committee in government/semi departments, and 40 Committee have been notified. A database is in progress to monitor the institutions still not have committees.
- 6. As a response to the notices a number institutions notified Committees such as the Governor Secretariat, CM Secretariat, Chamber of Commerce and a number of government and non-government institutions.

- 7. To ensure better communication and referral of harassment cases, a committee of the state human rights institutions has been formed and the first meeting is held on March 19, 2019
- 8. To ensure implementation of the law, a Provincial Watch Committee against Harassment was established in 2015 and since the last meeting held on April 4, 2016 committee was non-functional. The Committee with updated members has been notified and meeting was held on April 16, 2019.
- 9. To facilitate complainants at the district level, a team of Focal Persons (District Social Welfare Officer & District Attorney) has been notified, and the first orientation was held on March 26<sup>th</sup>, 2019, while the second orientation to the District Attorney's District Social Welfare Officers was held on March 23<sup>rd</sup>, 2019, with the support of UNDP.
- 10. In terms of compliance with the law, an institutional strengthening assessment has been conducted and 3 projects are finalised for the enhancement of institutional capacity to respond quickly and monitor the harassment trends and database. The funding institutions include UNDP, UN Women and the World Bank.
- 11. To ensure effective functioning of the Inquiry Committees, three orientation workshops conducted with selected members of the Committee from **Peshawar**, **Swabi**, **Kohat**, **Nowshera**, **Karak** and **Mardan**. The Toolkit on the law and the inquiry procedure will be provided to each committee member to ensure implementation of the law.
- 12. Awareness sessions conducted with universities, colleges, and a Facebook page has been launch to disseminate legal information and to engage with youth and young professional. In addition, capacity development programmes with duty bearers and CSOs and youth.

Through this notification, the designated District Social Welfare Officer has a responsibility to facilitate the complainants to reach the Ombudsperson Secretariat. The District Welfare Officers work includes assisting complainants, in particular, awareness raising on the Protection against Harassment of Women at the Workplace Act, 2010, charitable and non-governmental organizations engaged in promotion, protection and enforcement of human rights in their respective districts.
