REPLY

Yes:

- (a) The criteria for site selection of plantation under 10-BTAP are as under:-
 - 1. Government and private owned wasteland.
 - 2. Sufficient space for planting.
 - 3. Willingness of the land owner.
- (b) To address the issues of pollution regular planting campaign are being launched by the Forest Department each year with closed collaboration with the District Administration and other line departments, wherein all the line departments including Educational Institution, Health department, Police Department, TMAs, Revenue Department, etc assigned with the task of plantation. (Detail of plants provided to various organization is enclosed as Annex-A).

Free Distribution of plants to the general public are also carried out for planting the plants in their farmlands, houses, graveyards, etc besides this, departmental plantation in District Peshawar is also executed in order to control the issue of pollution. Detailed enclosed as **Annex-B**.
