WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. II of 2017), for the purposes hereinafter appearing.

It is hereby enacted by Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Police (Amendment) Act, 2020.

(2) It shall come into force from 11th July, 2020.

2. Amendment of section 32 of the Khyber Pakhtunkhwa Act No. II of 2017.---In the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. II of 2017), in section 32, for sub-section (1), the following shall be substituted, namely:

- "(1) The post of the Assistant Sub-Inspector shall be filled in the following manner:
 - (a) twenty per cent (20%), from amongst the Graduate Constables or Head Constables by selection on merit, subject to competitive examination, on the recommendations of the Public Service Commission, in the prescribed manner;
 - (b) fifty per cent (50%) from amongst the Head Constables, on the recommendations of the Departmental Promotion Committee, in the prescribed manner;
 - (c) twenty-five per cent (25%) by initial recruitment, through Public Service Commission, in the prescribed manner; and
 - (d) five per cent (05%) by initial recruitment, from amongst the wards of Shuhada of Police, on the basis of seniority to be determined with effect from the date of the martyrdom and their eligibility in the prescribed manner.".
