No.PA/Khyber Pakhtunkhwa/Bills-116/2020/6735.— The Khyber Pakhtunkhwa Delimitation of Local Councils (Repeal) Bill, 2020 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 07th September, 2020 and assented to by the Governor of the Khyber Pakhtunkhwa on 11th September, 2020 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA DELIMITATION OF LOCAL COUNCILS (REPEAL) ACT, 2020. (KHYBER PAKHTUNKHWA ACT NO. XXXVII OF 2020)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 15th September, 2020).

AN ACT

*to repeal the Khyber Pakhtunkhwa
Delimitation of Local Councils Act, 2015.*

WHEREAS the Election Commission of Pakistan has been empowered to delimit the village councils and neighbourhood councils for the elections of local councils in the Province of the Khyber Pakhtunkhwa under the Elections Act, 2017 (Act No. XXXIII of 2017);

AND WHEREAS pursuant to the above, the Khyber Pakhtunkhwa Delimitation of Local Council Act, 2015 (Khyber Pakhtunkhwa Act No. VI of 2015), has become redundant and accordingly requires to be repealed;

It is hereby enacted by the Provincial Assembly of the Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Delimitation of Local Councils (Repeal) Act, 2020.

(2) It shall come into force at once.

2. **Repeal.**---The Khyber Pakhtunkhwa Delimitation of Local Councils Act, 2015 (Khyber Pakhtunkhwa Act No. VI of 2015), is hereby repealed.
