No. PA/Khyber Pakhtunkhwa/Bills-29/2019/14100.— The Pakhtunkhwa Energy Development Organization (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 27th March, 2019 and assented to by the Governor of the Khyber Pakhtunkhwa on 1st April, 2019 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

further to amend the Pakhtunkhwa
Energy Development Organization Act, 1993

WHEREAS it is expedient further to amend the Pakhtunkhwa Energy Development Organization Act, 1993 (Khyber Pakhtunkhwa Act No. 1 of 1993), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.**---(1) This Act may be called the Pakhtunkhwa Energy Development Organization (Amendment) Act, 2019.

(2) It shall come in to force at once.

2. Amendment of section 18 of the Khyber Pakhtunkhwa Act No. 1 of 1993.--- In the Pakhtunkhwa Energy Development Organization Act, 1993 (Khyber Pakhtunkhwa Act No. 1 of 1993), in section 18, for sub-section (2), the following shall be substituted, namely:

“(2) The Organization, with the prior approval of the Board, shall have the Power to hand over power generation scheme or the part of the power plant of a multi-purpose scheme, having capacity not exceeding 2MW, carried out by it, to any agency of Government, local body, community base organization, non governmental organization or local community, as the case may be, in the best public interest, on such terms and conditions, as deemed appropriate by the Board.”.
