No. PA/Khyber Pakhtunkhwa/Bills-57/2020/796.— The Khyber Pakhtunkhwa Essential Personnel (Registration) (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 30th December, 2019 and assented to by the Governor of the Khyber Pakhtunkhwa on 8th January, 2020 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA ESSENTIAL PERSONNEL (REGISTRATION) (AMENDMENT) ACT, 2019. (KHYBER PAKHTUNKHWA ACT NO. II OF 2020)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 13th January, 2020).

further to amend the Essential Personnel (Registration) Ordinance, 1948.

WHEREAS it is expedient further to amend the Essential Personnel (Registration) Ordinance, 1948 (Ordinance No. X of 1948) for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.--- (1) This Act may be called the Khyber Pakhtunkhwa Essential Personnel (Registration) (Amendment) Act, 2019.
 - (2) It shall come into force at once.

- 2. Amendment of section 6 of the Ordinance No. X of 1948.--- In the Essential Personnel (Registration) Ordinance, 1948 (X of 1948), in section 6,—
 - (a) in sub-section (1), for the words "five hundred", the words "two thousand" shall be substituted; and
 - (b) for sub-section (3), the following shall be substituted, namely:
 - "(3) No Court shall take cognizance of the offence except on complaint lodged by or made on the authority of the Manager Employment Exchange, Khyber Pakhtunkhwa.".
