(KHYBER PAKHTUNKHWA ORD. NO. VII OF 2019)

AN ORDINANCE

further to amend the Khyber Pakhtunkhwa Finance Act, 2010

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Finance Act, 2010 (Khyber Pakhtunkhwa Act No. VIII of 2010), for the purposes hereinafter appearing;

AND WHEREAS the Provincial Assembly is not in session and the Governor of the Province of Khyber Pakhtunkhwa is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of powers conferred by Clause (1) of Article 128 of the Constitution of Islamic Republic of Pakistan, the Governor of the

Province of the Khyber Pakhtunkhwa is pleased to make and promulgate the following Ordinance:

- 1. Short title and commencement.---(1) This Ordinance may be called the Khyber Pakhtunkhwa Finance (Amendment) Ordinance, 2019.
 - (2) It shall come into force at once.
- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. VIII of 2010.--In the Khyber Pakhtunkhwa Finance Act, 2010 (Khyber Pakhtunkhwa Act No. VIII of 2010), in section 2, in sub-section (2),-
 - (a) in clause (a), in the table, against Serial No (i), in column 3, under the heading "Rate of tax", for the words "Two percent", the words "One and a half percent", shall be substituted;
 - (b) in clause (b), in the table, against Serial No (i), in column 3, under the heading "Rate of tax", for the words "Two percent", the words "One and a half percent", shall be substituted; and
 - (c) inclause (c), in the table, against Serial No (i), in column 3, under the heading "Rate of tax", for the figure and symbol "2%", the words "One and a half percent", shall be substituted.
