No. PA/Khyber Pakhtunkhwa/Bills-62/2020/6091.— The Khyber Pakhtunkhwa Land Acquisition (Amendment) Bill, 2020 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 21<sup>st</sup> February, 2020 and assented to by the Governor of the Khyber Pakhtunkhwa on 2<sup>nd</sup> March, 2020 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

*further to amend the Land Acquisition Act, 1894.*

**Preamble.** WHEREAS it is expedient further to amend the Land Acquisition Act, 1894 (Act No. I of 1894) for the purposes hereinafter appearing;

It is hereby enacted as follows:

**1. Short title and commencement.** — (1) This Act may be called the Khyber Pakhtunkhwa Land Acquisition (Amendment) Act, 2020.

(2) It shall come into force at once.

2. **Addition of new section in the Act No. I of 1894.**— In the Land Acquisition Act, 1894 (Act No. I of 1894), after section 55, the following new section shall be added, namely:

“56 **Bar of legal proceedings against Revenue Officer.** —No suit, prosecution or other legal proceeding shall lie against a Revenue Officer for anything done or intended to be done in good faith in pursuance of the provisions of this Act.”.
