No. PA/Khyber Pakhtunkhwa/Bills-223/2022/2323.— The Khyber Pakhtunkhwa Lissaail-e-Wal Mahroom Foundation (Amendment) Bill, 2022 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 01st August, 2022 and assented to by the Governor of the Khyber Pakhtunkhwa on 3rd August, 2022 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA LISSAAIL-E-WAL MAHROOM FOUNDATION (AMENDMENT) ACT, 2022. (KHYBER PAKHTUNKHWA ACT NO. XXXVII OF 2022)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa.

(Extraordinary), dated the 4th August, 2022).

AN ACT

further to amend the Khyber Pakhtunkhwa Lissaail-e-Wal Mahroom Foundation Act, 2015.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Lissaail-e-Wal Mahroom Foundation Act, 2015 (Khyber Pakhtunkhwa Act No. XXVI of 2015), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of the Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Lissaail-e-Wal Mahroom Foundation (Amendment) Act, 2022.
 - (2) It shall come into force at once.
- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the Khyber Pakhtunkhwa Lissaail-e-Wal Mahroom Foundation Act, 2015 (Khyber Pakhtunkhwa Act No. XXVI of 2015), hereinafter referred to as the said Act, in section 2,-
 - (a) after clause (b), the following new clause shall be inserted, namely;
 - "(b-i) "Chief Minister" means the Chief Minister of Khyber Pakhtunkhwa"; and

- (b) in clause (f), in sub-clause (ii), before the word "widows", the words "orphans and" shall be inserted.
- 3. Amendment of section 3 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the said Act, in section 3, in sub-section (1), the commas, words and quotes ", which, in Urdu may be named as "IDARA BARAI FALAH-E-NADARAN, KHYBER PAKHTUNKHWA" shall be deleted.
- Amendment of section 5 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the said Act, in section 5, in sub-section (2), for clauses (a) to (h), the following shall be substituted, namely:

"(a) Secretary to Government, Zakat, Ushr, Social Welfare, Special Education and Women Empowerment Department;

(b) Secretary to Government, Establishment Department;

Member

(c) Secretary to Government, Finance Department;

Member

(d) Chairman, Khyber Pakhtunkhwa Zakat and Ushr Council;

Member

(e) Chairperson, Khyber Pakhtunkhwa Commission on the Status of Women; Member

(f) four persons to be appointed by the Chief Minister for a period of three years on the recommendations of Search Committee from amongst the known philanthropists, retired civil servants in BPS-20 and above from PCS/PMS/PAS and members from civil society; and

Members

(g) Managing Director.

Member-cum-Secretary".

- 5. Amendment of section 6 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the said Act, in section 6,-
 - (a) in sub-sections (1), (2), (3), (4), (5), (7), (8) and (9), for the word "Government", wherever occurring, the word "Chief Minister", shall be substituted; and
 - (b) in sub-sections (2), (4), (5), (6), (7), (8) and (9), for the words, brackets and alphabets "clauses (f) and (g)" the word, brackets and alphabet "clause (f)" shall be substituted.
- 6. Amendment of section 7 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the said Act, in section 7,
 - (a) for sub-section (1), the following shall be substituted, namely:

- "(1) The Managing Director, with the approval of the Chairman, shall convene meetings of the Board, on such date and time as the Chairman may deem appropriate."; and
- (b) in sub-section (4), after the word "Board", the words "which shall include at least one ex-officio member and the Managing Director" shall be inserted.
- 7. Amendment of section 16 of the Khyber Pakhtunkhwa Act No. XXVI of 2015.---In the said Act, in section 16,-
 - (a) in sub-section (1), for clauses (a), (b) and (c), the following shall be substituted, namely:
 - "(a) grant by Federal Government;
 - (b) grant-in-aid by Government of such amount as it may deem fit to allocate every year;
 - (c) donations, financial assistance and funds by international and local donor agencies;" and
 - (b) after sub-section (2), the following new sub-section shall be added, namely:
 - "(3) The amount allocated by Government under subsection (1), shall be released to the Foundation within the same financial year.".
