No. PA/Khyber Pakhtunkhwa/Bills-30/2019/14801.— The Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 1<sup>st</sup> April, 2019 and assented to by the Governor of the Khyber Pakhtunkhwa on 10<sup>th</sup> April, 2019 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

#### **THE KHYBER PAKHTUNKHWA PROMOTION, PROTECTION AND ENFORCEMENT OF HUMAN RIGHTS (AMENDMENT) ACT, 2019 (KHYBER PAKHTUNKHWA ACT NO. XVIII OF 2019)**

*(First published after having received the assent of the Governor of the  
Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa,  
(Extraordinary), dated the 12<sup>th</sup> April, 2019).*

AN

ACT

to amend the Khyber Pakhtunkhwa Promotion, Protection  
and Enforcement of Human Rights Act, 2014.

**WHEREAS** it is expedient to amend the Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights Act, 2014 (Khyber Pakhtunkhwa Act No.III of 2014), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.**--- (1) This Act may be called the Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights (Amendment) Act, 2019.  
(2) It shall come into force at once.
- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No.III of 2014.**---In the Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights Act, 2014 (Khyber Pakhtunkhwa Act No.III of 2014), hereinafter referred to as the said Act, in section 2,-

(a) for clause (d), the following shall be substituted , namely:

“(d) “ Director General” means the Director General of Law and Human Rights;”;

(b) for clause (e), the following shall be substituted, namely;

“(e) “ Directorate General” means the Directorate General of law and Human Rights;”; and

(c) In clause (j), for the word “Directorate” the words “Directorate General” shall be substituted.”.

3. **Amendment of section 3 of the Khyber Pakhtunkhwa Act No.III of 2014.**--- In the said Act, in section 3,-

(a) In sub-section (1), for the words “Directorate of Human Rights” the words “Directorate General of Law and Human Rights” shall be substituted;

(b) In sub-section (2),-

(i) for the word “Directorate” the word “Directorate General” Shall be substituted; and

(ii) for the words “Director Human Rights” the words “Director General” shall be substituted; and

(c) In sub - sections (3) and (4), for the word “Director” the words “Director General” shall be substituted.”.

4. **Amendment of sections 5,6,7,8,9,10,11 and 12 of the Khyber Pakhtunkhwa Act No.III of 2014.**--- In the said Act, in sections 5,6,7,8,9,10,11 and 12 for the words “Directorate” and “Director” wherever occurring, the words “Directorate General” and “Director General” shall respectively be substituted.
