No. PA/Khyber Pakhtunkhwa/Bills-200/2022/9011.— The Khyber Pakhtunkhwa Public Service Commission (Amendment) Bill, 2022 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 21st March, 2022 and assented to by the Governor of the Khyber Pakhtunkhwa on 30st March, 2022 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION (AMENDMENT) ACT, 2022. (KHYBER PAKHTUNKHWA ACT NO. VIII OF 2022)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 31st March, 2022).

AN ACT

further to amend the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement. --- (1) This Act may be called the Khyber Pakhtunkhwa Public Service Commission (Amendment) Act, 2022.
 - (2) It shall come into force at once.

- 2. Insertion of new section 10B to the Khyber Pakhtunkhwa Ordinance No. XI of 1978.— In the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), after section 10A, the following new section shall be inserted, namely:
 - "10B. Validation of certain actions.---Notwithstanding anything contained in any law, rules and regulations for the time being in force, all the screening tests, conducted by the Public Service Commission, in syllabus based examinations, before the commencement of the Khyber Pakhtunkhwa Public Service Commission (Amendment) Act, 2022, under its regulations, in pursuance of which candidates have been selected and appointed as civil servants or have qualified the written examinations or have been called for interviews, shall deem to have been validly conducted for all intents and purposes under this Ordinance and rules made thereunder, and shall not be called in question in any court of law."
