No. PA/Khyber Pakhtunkhwa/Bills-14/2019/7650.— The Khyber Pakhtunkhwa Specific Relief (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 12th February, 2019 and assented to by the Governor of the Khyber Pakhtunkhwa on 22nd February, 2019 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA SPECIFIC RELIEF (AMENDMENT) ACT, 2019 (KHYBER PAKHTUNKHWA ACT NO. VIII OF 2019)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 27th February, 2019).

further to amend the Specific Relief Act, 1877

WHEREAS it is expedient further to amend the Specific Relief Act, 1877 (Act No. I of 1877), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.--- (1) This Act may be called the Khyber Pakhtunkhwa Specific Relief (Amendment) Act, 2019

(2) It shall come into force at once.

2. **Amendment of section 3 of Act No. I of 1877.**--- In the Specific Relief Act, 1877 (Act No. I of 1877) hereinafter referred to as the "said Act" in section 3, for the words bracket and figures "the Indian Succession Act (X of 1865)" the words comma and figures "the Succession Act, 1925" shall be substituted.

3. **Amendment of section 4 of Act No. I of 1877.**--- In the said Act, in section 4, in clause (c), for the words "Indian Registration Act" the words, comma and figures "the Registration Act, 1908" shall be substituted.

4. **Amendment of section 39 of Act No. I of 1877.**--- In the said Act, in section 39 and in illustration (c) thereunder, for the words "the Indian Registration Act" the words, comma and figures "the Registration Act, 1908" shall be substituted.
