further to amend the Khyber Pakhtunkhwa Universities Act, 2012.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012) for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Universities (Second Amendment) Act, 2020.
 - (2) It shall come into force at once.
- 2. Amendment of section 48 of the Khyber Pakhtunkhwa Act No. X of 2012.--- In the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012), herein after referred as the said Act, in section 48,-

- (i) in sub-section (2),-
 - (a) the word "and" as appearing at the end of clause (b), shall be deleted:

- (b) the full stop appearing at the end of clause (c), shall be substituted with a semi colon and thereafter the word "and" shall be inserted:
- (c) after the existing clause (c), as so amended, the following new clause shall be added, namely:
- (d) "(d) the Vice Chancellors of the Universities at Serial Nos. 25, 26 and 27 of the Schedule-I, appointed under their respective Regulations shall continue their services till expiry of their notified tenure."; and
- (ii) after sub-section (2), as so amended, the following Explanation shall: be added the end, namely:

"Explanation: For the purpose of this section "other legislative instruments" mean and includes the Regulations promulgated underthe repealed Article 247 of the Constitution, repealed by the Constitution (Twenty-fifth Amendment) Act, 2018) (Act No. XXXVII of 2018)".

- 3. Amendment of Schedule-I of the Khyber Pakhtunkhwa Act No. X of 2012.--- In the said Act, in Schedule-I, after serial No. 24, the following new entries shall be added, namely:
 - "25. The University of Malakand.
 - 26. The University of Swat.
 - 27. The Shaheed Benazir Bhutto University, Sheringal.
 - 28. The FATA University FR Kohat.".
