#### NOTIFICATION

Dated Peshawar, the 4th March, 2020.

No. PA/Khyber Pakhtunkhwa/Bills-95/2020/6243.— The National Disaster Management (Khyber Pakhtunkhwa) (Amendment) Bill, 2020 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 25<sup>th</sup> February, 2020 and assented to by the Governor of the Khyber Pakhtunkhwa on 2<sup>nd</sup> March, 2020 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE NATIONAL DISASTER MANAGEMENT (KHYBER PAKHTUNKHWA) (AMENDMENT) ACT, 2020. (KHYBER PAKHTUNKHWA ACT NO. XXI OF 2020)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 4th March, 2020).

### AN ACT

further to amend the National Disaster Management Act, 2010

Preamble,---WHEREAS it is expedient further to amend the National Disaster Management Act, 2010 (Act No. XXIV of 2010), for the purposes hereinafter appearing;

It is hereby enacted as follow:

- 1. Short title, extent and commencement.---(1) This Act may be called the National Disaster Management (Khyber Pakhtunkhwa) (Amendment) Act, 2020.
  - (2) It shall extend to whole of the Province of the Khyber Pakhtunkhwa.
  - (3) It shall come into force at once.
- 2. Insertion of new section 17(A) to Act No. XXIV of 2010.--- In the National Disaster Management Act, 2010 (Act No. XXIV of 2010), hereinafter referred to the said Act, after section 17, the following new section shall be inserted, namely:

- "17(A). Regularization of certain employees.---(1) Notwithstanding anything contained in any law or rules for the time being in force on the commencement of the National Disaster Management (Khyber Pakhtunkhwa) (Amendment) Act, 2020, all employees of the Project titled "Establishment of Federally Administered Tribal Areas (FATA) Disaster Management Authority in Federally Administered Tribal Areas (FATA) Secretariat (Phase-II), "ADP No. 1017 (2018-19)", who are holding various posts in the said Project, till the commencement of this Act, shall be deemed to have been validly appointed in the Provincial Disaster Management Authority, on regular basis, having the same qualification and experience for the said posts.
- (2) The seniority and other terms and conditions of service of the employees of the said project shall be determined in the prescribed manner.".
- 3. Insertion of new section 47(B) to Act No. XXIV of 2010.— In said Act, after section 47(A), the following new section shall be inserted, namely:
  - **"47(B).** Repeal, transfer of asset and liabilities.— (1) The S.R.O issued by the Federal Government vide S.R.O 302(1)/2008, dated 10<sup>th</sup> March, 2008, regarding application of National Disaster Management Ordinance, 2007 (LIII of 2007) to the Federally Administered Tribal Areas is hereby repealed.
  - (2) All assets, liabilities including employees, bank accounts, properties, debts, obligations, claims, proceedings before judicial forums,

alongwith all necessary record of the Federally Administered Tribal Areas Disaster Management Authority, shall be deemed to be assets, liabilities, bank accounts, properties, debts, obligations, claims, proceedings etc of the Provincial Disaster Management Authority under the Relief, Rehabilitation and Settlement Department of the Government.".
