I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on 26-04-2021 unanimously passed the following joint Resolution No.1088 moved by Mr. Inayatullah and Mr. Khushdil Khan Members Provincial Assembly Khyber Pakhtunkhwa as follows:-

"WHEREAS Article 27 of the Constitution of Islamic Republic of Pakistan provided for reserving posts for belonging to any class or area to secure their adequate representation in the service of Pakistan.

AND WHEREAS such arrangement was for not exceeding forty years from the commencing day of the Constitution which has been expired in the year of 2013.

THEREFORE, in order to avoid further illegality in the matter, this August House recommends to the Provincial Government to approach to the Federal Government for taking steps for amending Article 27 of the Constitution aiming to extend the period for the purpose for further twenty years."

I am further directed to say that under sub-rule (3) of rule 135 of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 1988 the Department concerned of the Government shall report to the Assembly Secretariat about the action taken on the resolution within a period of two months from the date of its communication
