The worthy Commissioner states that pursuant to the directions of this court, action has been taken against some marble factories as well as 102 hotels. However, he refers to WP No. 169-M of 2021 whereby an interim order has been extended in favour of some individuals. As such, the said writ petition is withdrawn from Hon'ble Mingora Bench (Dar-ul-Quza) at Swat to this court and be clubbed with the present petitions.

We have been informed by the worthy Commissioner that various leases have been given to the lessees by the Mines and Mineral Department, Government of Khyber Pakhtunkhwa. We wonder as to in what manner such leases were doled out to those persons who have not only destroyed the beauty of river Swat but in the process has turned it into a stream. It appears that the Tourism Department has also messed up the situation as they are merely interested in attracting tourists and in the process causing irreparable damage to the picturesque Swat Valley.

Accordingly, we nominate Syed Zaheerul-Islam, the worthy Deputy Commissioner Malakand Division as Focal Person to take all the necessary steps for the protection of the River Swat from being damaged in any manner by the so-called lease holders

We have been informed that over the period, River Swat is no more in its original shape on account of floods in the year 2010 which inundated several parts of Malakand Division and also due to the illegal activities of the power crushers. In this respect the worthy Commissioner states that a proper rehabilitation exercise be undertaken being the need of the hour. Accordingly, the learned AAG is directed to contact the Secretary Irrigation Government of Khyber Pakhtunkhwa to immediately make a survey of the River Swat and to hold in-depth meetings with all the stakeholders to devise a plan/strategy on war footing for the early rehabilitation of River Swat. The necessary report be shared with the court by the next date of hearing. Adjourned to 30.03.201.
