No. PA/Khyber Pakhtunkhwa/Bills-239/2022/6186.— The Khyber Pakhtunkhwa Ministers (Salaries, Allowances and Privileges) (Amendment) Bill, 2022 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 20<sup>th</sup> September, 2022 and assented to by the Governor of the Khyber Pakhtunkhwa on 10<sup>th</sup> October, 2022 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

#### **THE KHYBER PAKHTUNKHWA MINISTERS (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) ACT, 2022.**

**(KHYBER PAKHTUNKHWA ACT NO. XLIV OF 2022)**

#### **AN ACT**

further to amend the Khyber Pakhtunkhwa Ministers  
(Salaries, Allowances and Privileges) Act, 1975.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Ministers (Salaries, Allowances and Privileges) Act, 1975 (Khyber Pakhtunkhwa Act No. IV of 1975), for the purpose hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 2022.

(2) It shall come into force at once.

**2. Insertion of new section to the Khyber Pakhtunkhwa Act No. IV of 1975.**---  
In the Khyber Pakhtunkhwa Ministers (Salaries, Allowances and Privileges) Act, 1975 (Khyber Pakhtunkhwa Act No. IV of 1975), after section 7A, the following new section shall be inserted, namely:

**“7B. Usage of aircraft or helicopter etc.**---(1) The Chief Minister may use an aircraft or helicopter of Government, at Government expenses, for official use.

(2) The Chief Minister may hire an aircraft or helicopter from open market or requisition it from Pakistan Air Force or Federal Government for official use, at the cost of Government, in accordance with the rules made in this behalf by the Pakistan Air Force or Federal Government, as the case may be.

(3) The Chief Minister may allow a Minister or public servant to use an aircraft or helicopter of Government for official use at Government expenses.”.
