No. PA/Khyber Pakhtunkhwa/Bills-250/2022/5935.— The Upper Swat Development Authority (Amendment) Bill, 2022 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 19th September, 2022 and assented to by the Governor of the Khyber Pakhtunkhwa on 4th October, 2022 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE UPPER SWAT DEVELOPMENT AUTHORITY (AMENDMENT) ACT, 2022. (KHYBER PAKHTUNKHWA ACT NO. XLII OF 2022)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa. (Extraordinary), dated the 11th October, 2022).

AN ACT

to amend the Upper Swat Development Authority Act, 2021

WHEREAS it is expedient to amend the Upper Swat Development Authority Act, 2021 (Khyber Pakhtunkhwa Act No. II of, 2022), for the purposes hereinafter appearing:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.---(1) This Act may be called the Upper Swat Development Authority (Amendment) Act, 2022.
 - (2) It shall come into force at once.
- 2. Substitution of section 20 of the Khyber Pakhtunkhwa Act No. II of 2022.---In the Upper Swat Development Authority Act, 2021 (Khyber Pakhtunkhwa Act No. II of 2022), for section 20, the following shall be substituted, namely:
- **"20. Budget and accounts.---(1)** The Director General shall submit annual budget estimates and working plan to the Authority and the Authority may modify the said estimate or working plan to the extent of Authority's fund or grants as it may consider necessary.

- (2) The accounts of the receipts and expenditure of the Authority shall be kept in such form as may be prescribed by regulations.
- (3) The Director General shall within three (03) months of the close of each financial year, place before the Authority, the annual statement of accounts and audited balance sheet, profit and loss account and the auditor's report, for the preceding financial year.".
