In pursuance of policy issued by Government of Khyber Pakhtunkhwa Relief, Rehabilitation and Settlement Department notification No.SO(Estt)/RR&SD/3-10/2015/PDMA/Vol-VIII dated 12-06-2019 under clause 3c(i) which states "A bonafide citizen of Pakistan, domiciled in Khyber Pakhtunkhwa Province and not in government service of Pakistan or Provincial Government, who is the victim of a manmade disaster;" and 3c(ii) which states that "Civilian Victim is a person not being a terrorist or personnel of a law enforcement agency on duty or a government servant, who suffers harms to body or property loss due to any terrorist/extremist act and, in event of death of the person, includes legal heirs of the victim". The forum decided to drop the above 03 mentioned cases.






With strict adherence to the policy issued by Relief, Rehabilitation & Settlement Department KhyberPakhtunkhwa vide Notification No.SO(Estt:) RR&SD/3-10/2015/PDMA/Vol-VIII dated 12-06-2020, applications by 11 injured persons were submitted and after necessary scrutiny in pursuance to above referred notification issued by Relief, Rehabilitation & Settlement Department KhyberPakhtunkhwa only 08 cases were processed(**declared major injured by medical board**) and were provided compensation amount of Rs.200000 (Rs Two Lac only) each and 03 were dropped under the law.




