Subject: - AGENDA ITEM NO 10 (OTHER AGENDA ITEMS) OF ROAD TRANSPORT BOARD MEETING HELD ON 01/09/2022.

I am directed to refer to the subject cited above, referred in the minutes of the meeting of Road Transport Board (RTB) and to state that it is ~~inappropriate to call contract/fixd pay employees of RTB as regularized employees of Directorate of Transport & Mass Transit.~~

The reason is that after passage of private non-official bill as the Khyber Pakhtunkhwa Employees of Transport Department (Regularization of Services) Act, 2022 on 30/05/2022 and after tabling of another non-official bill namely The Khyber Pakhtunkhwa Employees of Transport Department (Regularization of Services) (Amendment Bill, 2022) moved by Nighat Yasmeen Orakzai, this Department has initiated two summaries for the Provincial Cabinet in response to these two non-official bills, in which the regularization of RTB contract-fixed pay employees, being employees of an autonomous body, has not been favored as employees of Directorate of Transport. Rather it has been proposed that such employees can be regularized only as employees of the Road Transport Board which is an autonomous statutory body corporate.

These summaries have yet to reach the Provincial Cabinet for appropriate decision which will be communicated to the provincial assembly with regard to the above two legislations. Secretary Provincial Assembly has also been requested that non-official bill may be tabled once the decision of Provincial Cabinet is communicated to the Provincial Assembly Secretariat.

In view of the above, I am directed to request you ~~not to treat RTB contract fixed pay employees as employees of Directorate of Transport & Mass Transit, Khyber Pakhtunkhwa in any way~~

It is added that RTB and Directorate of Transport & Mass Transit, Khyber Pakhtunkhwa are two distinct bodies with distinct functions. Allowing employees of one body to interfere in the affairs of another body is not permissible.
