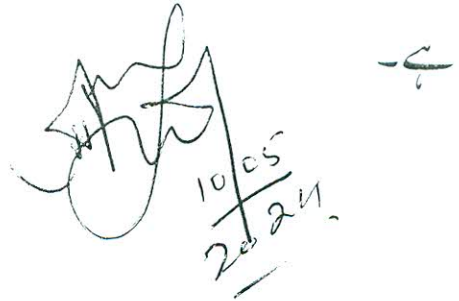


جناب اسپیکر!
