### NOTIFICATION

Dated Peshawar, the 19th January, 2011.

No.PA/Khyber Pakhtunkhwa/Bills/2011/4551. — The Gomal University (Amendment) Bill. 2011 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 07<sup>th</sup> January, 2011 and assented to by the Governor of the Khyber Pakhtunkhwa on 15<sup>th</sup> January, 2011 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

## THE GOMAL UNIVERSITY (AMENDMENT) ACT, 2011 (KHYBER PAKHTUNKHWA ACT NO. II OF 2011)

(first published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa (Extraordinary), dated the 19-1-2011).

> AN ACT

further to amend the Gomal University Act, 1974.

<u>Preamble.</u>—WHEREAS it is expedient to further amend the Gomal University Act, 1974 (N.W.F.P. Act No. X of 1974) for the purposes hereinafter appearing;

It is hereby enacted as follows;

- 1. Short title and commencement.—(1) This Act may be cited as the Gomal University (Amendment) Act, 2011.
  - (2) It shall come into force at once.
- 2. Amendment of section 2 of the Act No. X of 1974.— In the Gomal University Act, 1974 (N.W.F.P. Act No. X of 1974), hereinafter referred as the said Act, in section 2,—
  - (i) in paragraph (k) and wherever occurring in the said Act, for the words "North West Frontier Province", the words "Khyber Pakhtunkhwa" shall be substituted; and
  - (ii) after paragraph (m), the following new paragraph (mm) shall be inserted, namely,—
    - "(mm)"Pro Chancellor" means the Pro-Chancellor of the University;".
- 3. Amendment of section 3 of the said Act.— In the said Act, in section 3, in sub section (2), in clause (i), before the words "the Vice Chancellor", the words and comma "the Pro Chancellor" shall be inserted.
- 4. Amendment of section 5 of the said Act.— In the said Act, in section 5, in sub sections (1) and (4), for the words "Bannu and Dera Ismail Khan Districts and in North Waziristan Agency and South Waziristan Agency", the words "Dera Ismail Khan District and in South Waziristan Agency" shall be substituted.
- 5. Amendment of section 9 of the said Act.— In the said Act, in section 9, after clause (i), the following new clause (ia) shall be inserted, namely,—
  - "(ia) the Pro Chancellor;".
- 6. Amendment of section 10 of the said Act. In the said Act, in section 10,-
  - (i) in the marginal heading, after the word "Chancellor", the words "and Pro Chancellor" shall be inserted; and
  - (ii) after sub section (2), the following new sub section (2A) shall be inserted, namely,—

"(2A) The Minister for Higher Education, Khyber Pakhtunkhwa shall be the Pro Chancellor of the University and shall aid and advice the Chancellor in such manner as may be required by the Chancellor. The Pro Chancellor shall, in the absence of the Chancellor and Vice Chancellor, preside at the Convocation of the University."

- 7. Amendment of section 19 of the said Act.— In the said Act, in section 19,—
  - (i) in sub section (1), after clause (i), the following new clause (ia) shall be inserted, namely,—
    - "(ia) the Pro Chancellor;"; and
  - (ii) in sub section (2), after the words "Vice Chancellor", the words "or in his absence the Pro Chancellor" shall be inserted.
- 8. <u>Amendment of section 21 of the said Act.</u>— In the said Act, in section 21, in sub section (2), full-stop occurring at the end shall be substituted by semicolon and thereafter the following proviso shall be added, namely,—

"provided that the member mentioned at clause (ii) of sub section (1) shall hold office during the term of his tenure."
