No. PA/Khyber Pakhtunkhwa/Bills/2015/11189.—The Khyber Pakhtunkhwa (Amendment of Laws) Bill, 2015 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 23rd April, 2015 and assented to by the Governor of the Khyber Pakhtunkhwa on 30th April, 2015 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA (AMENDMENT OF LAWS) ACT, 2015

(KHYBER PAKHTUNKHWA ACT NO. XVIII OF 2015)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 5th May, 2015).

AN ACT

to amend certain laws.

Preamble.- Whereas it is expedient to amend certain laws;

It is hereby enacted as follows,-

- 1. Short title and commencement— (1) This Act may be cited as the Khyber Pakhtunkhwa (Amendment of Laws) Act, 2015.
- (2) It shall be deemed to come into force from the date of commencement of the Laws mentioned in column 3 of the Schedule to this Act.

2. <u>Amendment of certain laws.</u> The Laws mentioned in column 3 of the Schedule to this Act are hereby amended to the extent specified against each in column 4 of the said Schedule.
