No. PA/Khyber Pakhtunkhwa/Bills/2014/10643.—The Khyber Pakhtunkhwa Finance (Amendment) Bill, 2014 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 21<sup>st</sup> March, 2014 and assented to by the Governor of the Khyber Pakhtunkhwa on 27<sup>th</sup> March, 2014 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

**THE KHYBER PAKHTUNKHWA FINANCE (AMENDMENT) ACT, 2014**

**(KHYBER PAKHTUNKHWA ACT NO. XIX OF 2014)**

*(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 2nd April, 2014).*

**AN  
ACT**

*to amend the Khyber Pakhtunkhwa Finance Act, 2013*

**WHEREAS** it is expedient to amend the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for the purposes hereinafter appearing;

It is hereby enacted as follows:

**1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Finance (Amendment) Act, 2014.

(2) It shall come into force at once.

**2. Amendment of section 94 of Act No. XXI of 2013.—** In the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), in section 94, in sub-section (1), for the words and comma “any law, rules”, the words and comma “this Act or any other law or rules, for the time being in force” and for the words “Authority”, the words “Excise and Taxation Department of Government” shall respectively be substituted.

**3. Repeal.—**The Khyber Pakhtunkhwa Finance (Amendment) Ordinance, 2014 (Khyber Pakhtunkhwa Ordinance No. II of 2014) is hereby repealed.
