No. PA/Khyber Pakhtunkhwa/Bills/2016/4979.—The Khyber Pakhtunkhwa Local Government (Amendment) Bill, 2016 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 10th August, 2016 and assented to by the Governor of the Khyber Pakhtunkhwa on 15th August, 2016 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (AMENDMENT) ACT, 2016

(KHYBER PAKHTUNKHWA ACT NO. XIV OF 2016)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 18th August, 2016).

AN ACT

further to amend the Khyber Pakhtunkhwa Local Government Act, 2013

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purpose hereinafter appearing;

It is hereby enacted as follows:-

- 1. <u>Short title and commencement.</u>— (1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2016.
 - (2) It shall come into force at once.

- 2. Amendment of section 79 of the Khyber Pakhtunkhwa Act No. XXVIII of 20143— In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), hereinafter referred to as the said Act, in section 79, in sub-section (2), the colon at the end shall be replaced by full stop and thereafter the existing provisos thereunder shall be deleted.
- 3. Amendment in section 84 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.— In the said Act, in section 84, in sub-section (2), for the words "approve the budget", the words "approve the first budget" shall be substituted.
- 4. Repeal.— The Khyber Pakhtunkhwa Local Government (Amendment) Ordinance, 2016 (Khyber Pakhtunkhwa Ordinance No. VIII of 2016) is hereby repealed.
